

The Charity had recorded receipts of via donations and other income of £ 998.00 in the year to 31 Dec 2016. A break-up of the income is provided below:






The Trustees have reviewed the requirements for reserves in light of the main risks to the organisation. Trustees are committed to generating sufficient reserves to support current organisational activities to meet the following requirements:

- Safeguarding the commitment to service the community in the event of delays in receipt of donations or income
- Providing a financial cushion against risk and future uncertainties
- Generating a fund for the development of temple in / around Woking It is therefore proposed that a sum of £ 7,000 be set aside as Reserve Fund for the year 2017.
